

RESOLUTION NO. BLC24-0004

A RESOLUTION OF THE BUSINESS LICENSE COMMISSION OF THE CITY OF WEST HOLLYWOOD CONDITIONING THE CANNABIS LEGACY MEDICAL BUSINESS LICENSE NO. CLM-000001 FOR THE BUSINESS KNOWN AS FARMACY COLLECTIVE DBA MEDMEN WEHO, LOCATED AT 8208 SANTA MONICA BOULEVARD

The Business License Commission of the City of West Hollywood hereby resolves as follows:

SECTION 1: Farmacy Collective dba “MedMen WeHo”, is a Cannabis Legacy Medical Business that has a current business license through June 30, 2024.

SECTION 2: A public hearing was noticed and held by the Business License Commission on June 11, 2024, pursuant to Section 5.08.070 of the West Hollywood Municipal Code.

SECTION 3: Section 5.08.190 of the West Hollywood Municipal Code authorizes the Business License Commission to condition, suspend, modify or revoke a business license when violations of said business license are found to exist.

SECTION 4: The Business License Commission finds that the Farmacy Collective dba MedMen WeHo, has violated conditions of the Cannabis Operating Requirements and City’s Cannabis Ordinance set forth in Sections 5.70.043(b)(7), 3.36.040(n), and 5.70.070(b) of the West Hollywood Municipal Code.

SECTION 5: Based on the foregoing findings, the Business License Commission hereby denies the revocation of Cannabis Legacy Medical Business License No. CLM-000001 for the business known as MedMen WeHo, located at 8208 Santa Monica Boulevard, however since the findings for revocation can be made, the Commission instead determines to condition BLC21-0007 that if there are any other violations found to exist through December 31, 2027, the business license will be immediately brought back before the Business License Commission for a revocation hearing. This condition carries through on any business license renewal through this time period. Additionally, all past due tax obligations and penalties shall be paid by June 21, 2024.
